## 2<sup>nd</sup> AMENDMENT / CORRIGENDUM to TRANSFER/PLACEMENT GUIDELINES, 2018

Consequent upon decisions taken in the of meeting convened by the Chief Commissioner on 09.05.2019, the following amendments are hereby effected in the Transfer/Placement Guidelines, 2018 of Bhubaneswar GST, Central Excise & Customs Zone, issued vide C.No.I(22)38/CC/Admn/BBSR/2017/13015-034-A dated 20.04.2018.

2. Para 8.7 of the Transfer/Placement Guidelines, 2018 may be read as under:

3. One more clause i.e. clause (vii) is hereby added to Para 14.1, as under:

"(vii) Applications for posting by Superintendents, who have attended 55 years of age, may be considered for preferred place of posting."

4. Sub-para 9.2.4 is hereby added to Para "9.2: Rotation between Sensitive and Non-sensitive postings", as under:

"9.2.4 Superintendents or Inspectors who have completed sensitive posting in Central Preventive Units (CPU) of GST&CX Commissionerates should preferably not be re-posted in such units in their service career."

This issues with the approval of the Chief Commissioner, GST, Central Excise and Customs, Bhubaneswar Zone.
