
Please refer to your RTI application dated-10.10.2019 forwarded by the CPIO, GST & CX Commissionerate, Bhubaneswar (Copy enclosed) which is received in this office on 18-10-2019 on the above subject.

In this regard, the point-wise information sought vide the above referred RTI application, is furnished as under.

1. As per available records, no special audit was carried out between November-2014 to June-2015 as per the order of the Chairman.
2. There is no information in the available files regarding conduct of special audit (under Section 14A/14AA of Central Excise Act,1944) of M/s JSL, Jajpur, by the Audit Commissionerate between November-2014 to June-2017. However, it is revealed from the copy of FAR No.28/2014-15 dated 07.10.2016(Copy enclosed) available in the part file that a number of teams were constituted to conduct special audit of records of M/s. JSL,Jajpur for the year 2012-13 to 2014-15 under order No. C.No.V(1)101/IA/B-1/2013/661A dated 13.01.2016.
4. As per available records, no audit or special audit was carried out prior to November-2014 as Audit Commissionerate has been set up in the month of October-2014.

If you are not satisfied with the reply, you may file an appeal before First Appellate Authority, Office of the Commissioner (Audit), GST & Central Excise, C. R. Building, Rajaswa Vihar, Vanivihar, Bhubaneswar - 751007, State - Odisha within 30(thirty) days of receipt of this information.
