Sub: Unblocking of the facility for generation of E-Way- Reg.

Attention of the Trade, Industry, Taxpayers, Public and others concerned is invited to Notification No. 22/2019-Central Tax dated 23.04.2019 and Notification No. 33/2019-Central Tax dated 18.07.2019, issued by the Government of India, Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes & Customs, New Delhi. The said communication is available on CBIC website http://www.cbic.gov.in/.

- 2. As per the provisions of Rule 138 E of CGST Rules, 2017, E-Way Bill generation facility is blocked when a Taxpayer fails to file returns for two consecutive periods (Refer Notification No. 74/2018-Central Tax dated 31.12.2018). The taxpayer intending to restore the e-way bill generation facility (EWB-01) has to submit duly filled FORM GST EWB-05 (see Rule 138 E) manually to the Jurisdictional Principal Commissioner/ Commissioner.
- 3. The Principal Commissioner/ Commissioner, may, after due process, shall pass an order in FORM GST EWB-06 for permitting/ rejecting the application for unblocking of the facility for generation of E-Way Bill. After issuance of the said order (EWB-06), the same will be communicated to the taxpayer through GSTN portal. The taxpayers are advised to submit a copy of FORM GST EWB-05, along with other details, to Jurisdictional Division-Office also.
