The point wise reply to the information sought by the applicant is as under:

- 1. In calendar year 2019, thirty two Inspectors have been promoted to the grade of Superintendent on ad-hoc basis in terms of amendment in Superintendent of Central Excise Recruitment Rules, 1986 vide Gazettee Notification No. GSR 1206 (E) dated 13.12.2018 issued from F.No.A-12018/10/2012-Ad.IIB (part2) in Bhubaneswar Zone under CBIC.
- 2. The copy of aforesaid promotion order wherein thirty two Inspectors have been promoted to the grade of Superintendent on ad-hoc basis is enclosed.

On promotion, the above mentioned officers may exercise option for fixation of their pay under FR-22 (1) /a) (1) within one month from the date of promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt.(Pay-I) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.
 - 3. The concerned Commissioners shall ensure that if any of the officers whose name figures as aforesaid is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of Superintendent of Central Excise. If he is undergoing any penalty, he should be allowed to assume the charge of the post only after the expiry of the currency of the penalty period.

- 4. As per Para 8.6 of DoPT O.M. No.2/6/2009-Estt.(Pay-II) dated 25.02.2009; the officers who are presently working on deputation have to revert to their parent cadre. In case of officers working on loan basis also, the officers need to revert to their parent cadre. On promotion, the joining/taking over charge of such officers in the higher post shall be accepted in the parent zone only (CCO, Bhubaneswar Zone).
- 5. The promotion of the officers is subject to outcome of any litigation pending presently or arising in future, before any judicial forum etc.
- 6. The in-situ postings of the officers shall be effective till further orders/ AGT 2019.
