
Sub.: Information sought under RTI Act, 2005 - Case of Shri Pushpraj Singh of Uttar pradesh- regarding.

Please refer to your RTI application bearing Regn.No. CCEBW/R/E/20/00038 dated 21.09.2020, received in CCO on 21.09.2020 through RTI Request & Appeal Management Information System(RTI-MIS) seeking information under the provisions of Right to Information Act, 2005.

In this regard, it is to mention that you had already submitted three applications dated 06.11.2019, 26.02.2020 & 13.05.2020 seeking information and reply from this office had already been forwarded to you on 04.12.2019, 03.03.2020 and 20.05.2020 respectively. Moreover, by not taking the cognizance of the reply sent by this office on 20.05.2020 w.r.t to your RTI application dated 13.05.2020, you had also filed a First Appeal under Section 19(1) of the RTI Act,2005 to the First Appellate Authority, O/o the Chief Commissioner, CGST,CX & Customs, Bhubaneswar Zone wherein you had wrongly alleged that CPIO O/o the Chief Commissioner, CGST,CX & Customs, Bhubaneswar Zone has not furnished the answer or information in respect of your RTI application dated 13.05.2020. Subsequently, the First Appeal was disposed of in Virtual Personal Hearing(through Audio Conference) on 22.09.2020 by the the First Appellate Authority, O/o the Chief Commissioner, CGST,CX & Customs, Bhubaneswar Zone.

2. Since, in the fresh RTI application dated 21.09.2020, you have sought the reason for non-selection of a particular candidate and information sought is not clear, so, this office is not in a position to furnish the same. Further, this office is running with skeletal staff due to COVID-19. Hence, you are advised to inspect the concerned file in person, if you wish to.
