- 4. In terms of para 17.12 of DoP&T O.M. No. 22011/5/86-Estt. (D) dated 10.04.1989 (as amended) "when an employee does not want to accept a promotion which is offered to him, he may make a written request that he may not be promoted and the request will be considered by the Appointing Authority, taking relevant aspects into consideration. Further, where the reasons adduced by the officer for his refusal for promotion are not acceptable to the Appointing Authority, then he should enforce the promotion of the officer and in case the officer still refuses to be promoted, then even disciplinary action can be taken against him for refusing to obey his order."
- 5. On promotion, the above mentioned officers may exercise option for fixation of their pay under FR-22 (1) /a) (1) within one month from the date of this order in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt.(Pay-I) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.
