
Sub- Promotion to the cadre of STA/EA - withdrawal of promotion order-reg.

A review DPC was held on 06.01.2021 to scrutinize the eligibility of candidates considered by the DPC held on 16.12.2020 which recommended promotion of 10 Tax Assistants to the cadre of STA(EA). The Committee observed that there was a mis-interpretation in counting qualifying service in respect of ICT transferee. The Committee found that none of the candidates had completed 3 years of regular service as on 01.04.2016 in this zone for being eligible for promotion to the grade of STA in terms of Recruitment Rules, 2003.

On the recommendation of the review DPC held on 06.01.2021, Order No.55/ET/CCO/BBSR/2021 dated 16.12.2020 issued from C. No. II (3)5/ET /CCO/BBSR/2018 promoting 10 Tax Assistants of GST, Central Excise & Customs, Bhubaneswar Zone to the grade of Senior Tax Assistants (re-designated as Executive Assistant) in Level-6 of Pay Matrix w.e.f. 01.04.2016 is hereby withdrawn with immediate effect.

Consequently, 10 Tax Assistants promoted vide Order No.55/ET/CCO/BBSR/2021 dated 16.12.2020 stand reverted to the grade of Tax Assistant in Level-4 of Pay Matrix with immediate effect.

This issues with the approval of Competent Authority.
