2. संबंधित प्रधान आयुक्त / आयुक्तों / नियंत्रण अधिकारी द्वारा उपरोक्त अधिकारियों को **20.09.2021** अथवा उससे पहले उनके वर्तमान तैनाती स्थान से कार्यमुक्त कर दिया जाए।

The above mentioned officers must be relieved from their present place of posting by the respective Principal Commissioner/ Commissioners/ Controlling Officers on or before **20.09.2021** positively.

3. आगे यह भी निदेश दिया जाता है कि संबंधित आयुक्तालयों द्वारा दिनांक **17.09.2021** तक आयुक्तालय के अधीन विनिर्दिष्ट प्रभार संबंधी आदेश जारी कर दिए जाए। संबंधित प्रधान आयुक्त / आयुक्तों द्वारा विनिर्दिष्ट प्रभार संबंधी आदेश जारी करते समय स्थानांतरण तैनाती गाइडलाइंस, 2018 (यथासंशोधित) तथा अधिकारियों की तैनाती विवरण (History of Posting) को ध्यान में रखा जाए ताकि उचित रोटेशन / संवेदनशील तथा असंवेदनशील मानकों इत्यादि सुनिश्चित किया जा सके। स्थानांतरण / तैनाती गाइडलाइंस में किसी भी प्रकार के विचलन के मामले में संबंधित प्रधान आयुक्त / आयुक्तों द्वारा मुख्य आयुक्त का पूर्व अनुमोदन लिया जाना चाहिए।


It is further directed that specific charge/ postings within the Commissionerate should be issued by **17.09.2021** by the respective Commissionerates. While issuing orders for specific charge/ postings by the respective Principal Commissioner/ Commissioners, the Transfer/ Placement Guidelines 2018 (as amended) and History of Posting (HoP) of the officers should be kept in mind, so as to ensure proper/ rotation/ sensitive & non-sensitive norms etc.. In case of any deviation from the Transfer/ Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Principal Commissioner/ Commissioners.
