Attention of all the Customs Brokers and other stakeholders working in Customs(Preventive) Commissionerate, Bhubaneswar is invited to the newly launched functionalities of Customs Brokers Licensing Management System (CBLMS) online portal (https://cblms.gov.in).

- 5. In view of the above, all the Customs Brokers are requested to ensure that their respective CB profiles are completely validated and replies to any deficiencies/queries raised by their respective policy sections are submitted on priority.
