Sub:-Examination of 'G' Card under Regulation 13(5) of Customs Broker Licensing Regulations, 2018- Reg.

Attention of all the stakeholders working in the jurisdiction of Customs (Preventive) Commissionerate, Bhubaneswar are hereby informed that it is proposed to hold an examination in the month of <u>February-2024</u> for Category of 'G' under Regulation 13(5) of the Customs Brokers Licensing Regulations, 2018.

- **2**. The Category 'G' examination shall include a written examination and oral examination. The Applicant may avail a maximum of four chances/attempts to qualify in the written examination. Non-appearance in any written examination after registration will not be counted as a chance/ attempt.
- **3**. Desirous candidates meeting the eligibility criteria as mentioned below may apply in the prescribed Form annexed to this Public Notice:

#### Eligibility criteria:

An employee/director/partner of Customs Broker, who have passed 10+2 or equivalent exam.

- **4.** The Application duly sponsored by the Customs Brokers should be submitted in the format as prescribed in the Proforma enclosed as Annexure-A to this Public Notice. Applicants may ensure furnishing full postal address for communication, email address and the mobile number properly for prompt communication from this end. The Application should be accompanied by the following documents:
  - a. Duly filled Annexure A (Application Form)
  - b. Duly filled Annexure B( Declaration)
  - c. Duly filled Annexure C (Admit Card in duplicate)
  - d. Copy of the Applicant's valid 'H' card, duly attested by the Customs Broker.
  - e. Three recent passport-size-colored photographs of the Applicant (One photo pasted on the Application Form duly attested by the Customs Broker and two photos pasted on the Admit Card)

- Copy of Customs Broker License/ Commissionerate's endorsement letter, as the case may be duly attested by the Customs Broker.
- g. The Salary Certificate of the Applicant issued by the sponsoring Customs Broker.
- h. TR-6 Challan of Rs. 500/- as Examination Fee paid in favor of the Commissioner of Customs (Preventive) Commissionerate, Bhubaneswar.
- Consent Letter Certificate in respect of the Applicant issued by the sponsoring Customs Broker.
- Self-attested copy of address proof (permanent and present) of the Applicant.
- k. Self-attested copy of the Aadhaar Card of the Applicant.
- Self-attested copy of the Applicant's educational qualification (10+2 or equivalent).
- **5**. The Application Form complete in all respects along with all enclosures as mentioned in Para 4 above shall be submitted in person at the Centralized Dispatch Section, at 4th floor of the Office of the Commissioner of Customs (Preventive), Bhubaneswar, C. R. Building (GST BHAWAN), Rajaswa Vihar, Bhubaneswar-751007, on or before **19.01.2024** up to 1800 hrs. No Application Form shall be received in CBLR Section or elsewhere in the Commissionerate.
- **6.** Before submitting the Application, the Applicant must ensure completeness of the Application. The Applications which are incomplete or not affixed with self-attested photograph or received after the stipulated date and time shall be rejected, without any information to the Applicant. No correspondence in this regard shall be entertained by this office.
- 7. All Customs Brokers are advised to ensure that the information given in respect of their employees are true. Any mis-declaration will be viewed seriously and suitable action will be taken against the Customs Broker in accordance with CBLR, 2018. Customs Brokers are also required to ensure that the H- Card held by the Candidates are duly renewed well in advance, if the same expires before the date of examination. Candidates holding invalid/expired H-Cards will not be allowed to appear in the Examination. In case any candidates leave their job after submitting application for the Examination, the concerned Customs Broker should forthwith report the matter to this office and surrender the original H-Card held by such candidate.
- 8. The Roll Numbers of the candidates, date, time and venue of the examination will be displayed on the Notice Board after scrutiny of the Applications. Hall tickets for written examination and intimation about oral examination will be communicated through speed post & e-mail.
- **9.** The 'G' Card Examination shall comprise of a written and oral examination. The marking scheme of 'G' Card Examination will be, +2 for each correct answer & -1 for each incorrect answer and minimum qualifying marks will be 50%. The syllabus for the examination will be as per Annexure 'E' to this Notice. The written examination will be for 100 marks & oral examination will be for 50 marks.

- 10. It may be noted that if any suppression or willful mis- statement of any factual or material information in the Application is noticed at any stage even after declaration of the result, the Candidate would be treated as disqualified from the examination and in addition the Candidate/ Customs Broker will also be liable for appropriate action under the provisions of CBLR, 2018/ or any other law for the time being in force.
- 11. The decision of the Commissioner of Customs (Preventive), Bhubaneswar will be final in all respects of the examination.

#### INSTRUCTIONS

- 5. Candidate shall not leave the examination hall without prior permission of the Invigilator/Supervisor.
- 6. Candidate after completing their answers should remain seated until their answer books are collected.
- 7. Silence must be strictly observed in the examination hall.
- 8. Carrying Mobile phones, calculator or any other scientific devices is strictly prohibited in the examination hall.
- 9. Any mal-practice in the examination hall shall be prohibited. If found guilty, then their 'H' Pass certificate may be even cancelled by the department.
