The Commissioner of erstwhile Central Excise, Service Tax and Customs, Bhubaneswar-I Commissionerate, in exercise of the powers conferred under Section 8(b) of the Customs Act'1962, had specified the limits of Customs Area in respect of ICD, Kalinganagar by M/s Apeejay Logistics Park Pvt. Ltd. vide Customs Notification No. 01/2012 dated 15.10.2012 comprising 12.69 acres (51372.33 Sq. Mtrs.).


M/s Apeejay Logistics Park Pvt. Ltd. having their registered office at Khurunti, Kalinga Nagar Industrial Complex, Jajpur, vide their application dated 18.02.2024 have requested to de-notify 4.52 acres of land from South Side of ICD Kalinganagar area and 0.36 acres from North East Side of ICD Kalinganagar totaling 4.88 acres (19748.66 Sq. Mtrs.) out of existing 12.69 acres (51372.33 Sq. Mtrs.) of aforesaid Customs Notified Area and specify remaining 7.81 acres (31605.95 Sq. Mtrs. ) of Customs Area.

Now, on the basis of the request of the Custodian, and further, in terms of powers conferred under Section 8(b) of Customs Act, 1962, I, Madhab C Mishra, Commissioner of Customs ( Preventive) Commissionerate, Bhubaneswar hereby de-notify an area of 4.88 acres of ICD, Kalinganagar by M/s Apeejay Logistics Park Pvt. Ltd. and specify the limits of Customs Area of ICD, Kalinganagar by Apeejay Logistics Park Pvt. Ltd. at Khurunti, Kalinga Nagar Industrial Complex, Jajpur comprising 7.81 acres (31605.95 Sq. Mtrs.) as under:

On East Side	Approach road of M/s BRPL by 152.610 meters long boundary wall
On West Side	Factory premises of M/s Neelanchala Ispat Nigam Ltd. by 289.314 meters long boundary wall
On North Side	Factory premises of M/s BRPL. by 226.229 meters long boundary wall
On South side	De-notified Customs Area domestic cargo handling area of M/s ALPPL by 277.563 meters long boundary wall & encompassing State Highway No. 214 connecting Duburi Square to Panikoili.
