- In compliance with the direction issued vide Para-3 of CCO letter C. No. I(8)36/CC/Admn/BBSR/2017/16233A dated-26.06.2024 as stated above, the Principal Commissioner, GST & CEX Commissionerate Bhubaneswar has been pleased to approve following instructions/guidelines towards ensuring smooth operation of the booking of two departmental guest houses situated at Bhubaneswar & Puri and proper monitoring of the aforesaid newly opened Bank Account for this purpose:-
 - Booking of the above two Guest Houses are to be made by the officer posted in CCO looking after booking of Guest Houses against receipt of room rent in advance through online mode. Bank particulars are to be conveyed to the applicant for online payment by him.



- 2. Upon receipt of the booking amount, officer in CCO would inform the Guest House in charge about the details of occupant, dates of stay and payment particulars for entry in relevant register maintained/to be maintained in the Guest Houses.
- 3. Those who couldn't make online payment in such case, cash will be collected at the Guest House against issuance of receipt. The said money will be deposited in the bank the very next day.
- 4. A monthly report to be sent by the officer in CCO looking after Guest Houses booking to this office for reconciliation purpose containing details of total number of booking and amount collected through above mode in the previous month by 10th of every month.
- 5. Such collection of tariff in those two Guest Houses will be used for laundry expenses and basic maintenance activities pertaining to them.
