### NOTICE NO. 02/2025

जीएसटी, केन्द्रीय उत्पाद शुल्क एवं सीमा शुल्क, भुवनेश्वर जोन के ग्रुप - बी (राजपत्रित), ग्रुप - बी (अराजपत्रित), ग्रुप - सी (मंत्रिस्तरीय/गैर मंत्रिस्तरीय) संवर्ग का वार्षिक सामान्य स्थानांतरण (AGT), 2025 शीघ्र ही प्रभावी होने की संभावना है। 31 मई तक के कार्यकाल को ध्यान में रखा गया है और विशेष आयुक्तालयों में 9 महीने और उससे अधिक के कार्यकाल को 1 वर्ष मान लिया गया है।

Annual General Transfer, 2025 for officers of Group-'B' (Gazetted), Group 'B' (Non-Gazetted), Group 'C' (Ministerial/Non-Ministerial) Cadres of Bhubaneswar Zone, is likely to be effected shortly. The tenure upto 31<sup>st</sup> May was taken into account and tenure of 9 months and above in particular commissionerates were rounded off to 1 year.

2. जिन अधिकारियों का स्थानांतरण किया जाना है उनकी सुची संलग्न है। उपर्युक्त सुची में किसी भी प्रकार की विसंगती पाए जाने पर 15<sup>th</sup> मार्च, 2025 तक अधीहस्ताक्षरी की सुचना में लाया जाए, अन्यथा इस पर विचार नहीं किया जाएगा।

The due list of officers liable for transfer has been enclosed. In case of any discrepancy, with regard to due list, the same should be brought to the notice of the undersigned directly by 15<sup>th</sup> March, 2025, failing which, the same would not be considered.

3. ट्रांसफर/प्लेसमेंट गाइडलाइन्स, 2018 तथा ट्रांसफर/प्लेसमेंट गाइडलाइन्स, 2018 के परिशिष्ट के अनुसार जो अधिकारी स्थानांतरण चाहते हैं, वे अपना अभ्यावेदन, यदि कोई हो, अनुलग्नक - ए में दिए गए निर्धारित प्रपत्र में प्रस्तुत करेंगे। अधिकारी अपनी प्राथमिकता के आधार पर क्रमवार पांच स्टेशनों का विकल्प प्रस्तुत कर सकते हैं तथा नियंत्रण अधिकारी / उचित माध्यम से ही अभ्यावेदन प्रेषित करें। मुख्य आयुक्त कार्यालय को सीधे / अग्रिम प्रतियों में प्रेषित किए गए आवेदनों पर विचार नहीं किया जाएगा।

Officers who are likely to be transferred as per the Transfer/ Placement Guidelines, 2018 & addendum to Transfer/ Placement Guidelines, 2018 should submit their representations, if any, in the prescribed format (Annexure-A). Officers may also indicate their option of place of posting giving five stations in order of preference and should submit same through their controlling officer/ proper channel. **Application submitted directly/ advance copy to CCO shall not be considered under any circumstances.**

क्रमशः पृष्ठ-1/-

4. यह निर्देश दिया जाता है कि प्रधान आयुक्त / आयुक्त द्वारा अपने-अपने क्षेत्राधिकार में इस परिपत्र की तारीख से एजीटी-2025 कार्य के पूरा होने तक स्टेशन परिवर्तन से संबंधित कोई स्थानांतरण / रोटेशन आदेश (LRs) जारी नहीं किया जाना चाहिए। हालांकि, गंभीर और असाधारण परिस्थितियों में ऐसे एल.आर आदेश प्रधान आयुक्त/आयुक्त द्वारा मुख्य आयुक्त के पूर्वानुमोदन से जारी किए जा सकते हैं।

It has been directed that no transfer/rotation orders (LRs) involving change of station should be issued by the Pr. Commissioners/ Commissioners in their respective jurisdictions from the date of this circular till the completion of AGT-2025 exercise. However, in case of grave and exceptional circumstances such LR orders may be issued by the Pr. Commissioners/ Commissioners/ with the prior approval of the Chief Commissioner.

5. अभ्यावेदन प्रेषित करने से पूर्व वे सुनिश्चित करें कि:

While forwarding the representation they should ensure that:

(i) अभ्यावेदन में समस्त तथ्य सही हैं;

The representations are correct on facts;

(ii) अगर समय से पूर्व स्थानांतरण चाहते हैं, तो स्थानांतरण का कारण विनिर्दिष्ट किया जाना चाहिए। अभ्यावेदन में यदि कोई गलत / झूठा कारण दर्शाया गया होगा तो उसे रद्द कर दिया जाएगा ;

In case of pre-mature transfer, the grounds of the transfer should be specifically mentioned. Representation containing vague/arbitrary grounds will be summarily rejected;

(iii) अभ्यावेदन में किसी विशेष स्थान का जिक्र होना चाहिए न कि किसी विशेष तैनाती का ;

Representation may be made for posting to a particular station and not for any particular posting;

(iv) अनुकंपा आधार के अनुरोध के लिए, उचित प्रमाण / दस्तावेजी साक्ष्य, इत्यादि संलग्न होने चाहिए।

For compassionate requests, proper proof/ documentary evidence etc. should be enclosed.

6. अभ्यावेदन को उचित आधार सहित संबंधित नियंत्रण अधिकारियों के माध्यम से ही प्रेषित किया जाए, जैसा भी मामला हो, इस नोटिस के जारी होने की तारीख से 15 दिनों के भीतर इस कार्यालय में पहुंच जाना चाहिए, (नवीनतम 15 मार्च 2025 तक)।

The representation along with the grounds must be routed through the respective controlling officers, as the case may be and should reach this office **within 15 days from the date of issue of this notice (latest by 15<sup>th</sup> March, 2025).**

7. केंद्रीय सिविल सेवा (आचरण) नियमावली, 1964 के नियम 20 की ओर भी ध्यान आकृष्ट किया जाता है, जिसके तहत "कोई भी सरकारी कर्मचारी अपनी सरकारी सेवा संबंधी मामलों में अपने हितों के लिए अपने वरिष्ठ प्राधिकारी पर किसी भी प्रकार की राजनीतिक अथवा अन्य बाह्य प्रभाव डालने का प्रयास नहीं करेगा"। तदनुसार, उपरोक्त नियम के प्रावधानों का सख्ती से पालन किया जाए तथा स्थानांतरण/ तैनाती हेतु कोई भी बाह्य प्रभाव नहीं डाला जाए, अन्यथा इसे गंभीरता से लिया जाएगा।
